- 6. I understand and acknowledge that there are potential risks involved related to alcohol consumption. I hereby assume all risks, known and unknown, foreseeable and unforeseeable, in any way connected with my consumption of alcohol at the Association event. I accept full responsibility for any liability, injury, loss, damage, or death in any way connected with my consumption of alcohol at the Association event. I acknowledge that I alone am responsible for all of my actions resulting from consuming alcohol and the Association and its members, managers, directors, officers, and committee members are in no way responsible.
- 7. I hereby waive, release, and discharge the Association and its members, managers, directors, officers, and committee members from and against any and all claims of liability that I may have or that may result from, or be related to, my consumption of alcohol at the Association event regardless of cause. I hereby agree not to sue the Association and to indemnify and hold harmless the Association and its members, managers, directors, officers, and committee members from and against any and all claims, liabilities, losses, demands, and costs (including reasonable attorney fees) including any property damage, personal injury, or death that I may suffer or that may result from my consumption of alcohol at the Association event regardless of cause.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT, ASSURANCE OR GUARANTEE BEING MADE TO ME AND INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.
